GMAHA Housing Choice Voucher (HCV) Administrative Plan Revisions Effective Date of Change: November 01, 2022

The Greater Metropolitan Area Housing Authority Housing Choice Voucher (HCV) Administrative Plan has been brought current with all recent HUD requirements and guidance, including the following:

- The addition of a brand new Chapter 19 on Special Purpose Vouchers
- Minor updates for Notice PIH 2020-19 on what constitutes an "assisted unit" for rent reasonableness determinations
- Additions regarding EIV system searches as discussed in Notice PIH 2018-18, the March 2021 EIV FAQs, and the EIV system training conducted September 30, 2020
- Updates regarding the PHA's ability to conduct remove video inspections (RVIs) as specified in Notice PIH 2020-31
- Modifications to account for Notice PIH 2020-32 on conducting remote informal hearings and briefings
- Removal of the Section 3 PBV owner compliance requirement per the October 2020 Section 3 final rule
- Revisions for Executive Order 13988 regarding discrimination on the basis of sexual orientation and gender identity
- Updates to include 40 CFR 745.227 as part of the required lead-based paint regulations in accordance with the EPA-updated the dust-lead clearance levels
- Other clarifications and modifications to reflect industry best practices, and to ensure that the content is user-friendly, current, and in compliance with all recent HUD regulations and guidance
- The addition of the Statewide Referral Network (SRN) referrals as a wait list preference.
- Changes to incorporate guidance from HUD's new HCV Guidebook chapters
- Revisions regarding Notice PIH 2022-18 on the use of administrative fee funding for "other expenses"
- Updates to account for the final rule, "Streamlining and Implementation of Economic Growth, Regulatory Relief, and Consumer Protection Act Changes to Family Self-Sufficiency (FSS) Program," published May 17, 2022
