Request for Proposal General Contractor / Construction Management Services

A. OBJECTIVE

Greater Metropolitan Area Housing Authority of Rock Island County, ("GMAHA"), Rock Island County, Illinois, is soliciting proposals from an experienced general contractor / construction manager to partner on potentially two (2) RAD conversion projects: 1) a multi-phased Rental Assistance Demonstration conversion of one of its oldest public housing assets. This includes 151 existing public housing residential units; 2) A rehabilitation of 96 elderly designated units converting through the RAD program. It is the intent that the selected contractor(s) will participate as a member of the Development Team for one or both GMAHA's affordable housing construction projects.

HUD created RAD to enable public housing authorities to convert public housing units to long-term Section 8 project-based vouchers – either project based rental assistance administered by HUD or project-based vouchers administered by the GMAHA. One of the main objectives of RAD is to address the large back-log of capital needs that has accumulated over the years for the million units of public housing. This back-log is estimated by HUD to be over \$50 billion dollars.

Today, the Capital Fund Program provides the primary source of funding for public housing repairs and renovations. However, Capital Fund annual appropriations have consistently fallen below the amounts required to keep pace with basic capital needs. These chronic funding shortfalls have contributed to the loss of tens of thousands of public housing units in the past fifteen years, only a fraction of which have been redeveloped.

Under RAD, the GMAHA would essentially exchange operating and capital subsidies under the Public Housing program for long-term Section 8 project-based rental assistance contracts. Property-based Section 8 contracts would provide the GMAHA access to private financing to renovate public housing properties, consistent with other Federally-assisted housing programs. Private financing could take the form of loan proceeds (debt), equity, and/or grants, tax credits and essential function bonds.

The GMAHA is applying to HUD to convert approximately 151 units at AMP 1 of its remaining public housing portfolio under the RAD application. If approved by HUD, the GMAHA will work with the development team to: demolish and dispose of aging units, replace obsolescent infrastructure, manage the construction of new single family, multifamily and potential mixed-use buildings.

Additionally, the GMAHA has an approved RAD application for its William Young Apartments (AMP 5), which consists of 96 elderly units requiring interior and exterior renovations and infrastructure improvements.

C. SUBMISSION PROCESS

All Proposals are due and must be delivered to the Greater Metropolitan Area Housing Authority of Rock Island County on or before August 13, 2025 at 4:00 p.m. CST. Proposals submitted late or via oral, telephonic, telegraphic, electronic mail or facsimile **will not** be considered or accepted.

Each Bidder must submit one (1) original Proposal and three (3) additional Proposal copies and four (4) copies of the Proposal Fee in a separate sealed envelope contained within the bidders sealed proposal. Proposal submitted must be clearly marked: **RFP – Affordable Housing Developments General Contractor / Construction Management and then list Bidders name and address. Proposals shall be arranged in the following format and sequence:

- A. A cover letter describing your Firm's understanding of the engagement, providing the name, title and telephone number of the person authorized to negotiate and contractually bind the Firm.
- B. A narrative responding to the specific evaluation criteria listed below.
- C. Completed Attachments (which are routine requirements of all Requests for Proposals issued by the GMAHA).
- D. Respondents should identify any conflicts or propriety information.

All Proposals received on or before the Due Date will be publicly opened and recorded immediately. No immediate decisions are rendered.

Hand delivered Proposals will be date/time stamped/signed by the CEO or by her designee at the address above in order to be considered. Normal business hours are 8:00 a.m. to 4:00 p.m. Monday through Friday.

The GMAHA will not be liable to any Bidder for any unforeseen circumstances, delivery or postal delays. Postmarking on the Due Date will not substitute for receipt of the Proposal. Each Bidder is responsible for submission of their Proposal.

Additional time will not be granted to a single Bidder; however, additional time may be granted to all Bidders when the GMAHA determines that circumstances warrant it.

To be considered, each firm must submit a response to this RFP using the format provided herein. No other distribution of proposals is to be made by the submitter.

The proposal must be signed in ink by an official authorized to bind the submitter to its provisions. Each proposal must remain valid for at least ninety days from the due date of this RFP.

Proposals should not include any plastic covers, binders, or other non-recyclable materials. The GMAHA will rate and rank all proposals received by the deadline according to evaluation criteria established herein. Responders may be asked to participate in a telephone or personal interview if they are among the top-rated responses.

The GMAHA reserves the right to reject any and all submissions, to waive informalities and minor irregularities in submissions deemed to be in its best interests.

Any response may be withdrawn prior to award of the contract(s).

GMAHA reserves the right:

- A. To waive informalities required herein;
- B. To request additional information;
- C. To supplement, amend or otherwise modify the terms of the schedules set forth herein;
- D. To conduct all investigations and background checks necessary for adequate evaluation; and
- E. To decide in its sole discretion, not to select any of the proposals and / or re-submit this proposal for additional consideration if no satisfactory responses are received;
or
- F. To decide to selection multiple contractor, as necessary and appropriate, for various phases of the redevelopment project

All costs directly or indirectly related to preparation of a Response to the Request for Proposals or any oral presentation required to supplement and/or clarify the submittal which may be required by GMAHA shall be the sole responsibility of and shall be borne by Respondent(s).

D. SCOPE OF SERVICES

This RFP is intended to serve one purpose: 1) to procure one or multiple, depending on project(s) need, general contracting or construction management firm(s) to work directly with GMAHA and its development team on the redevelopment plan for the Oak Grove neighborhood and / or construction management of William Young apartments. This plan includes a mix of new construction, rehabilitation, mixed use and major infrastructure improvements including new roads and sidewalks and systems.

The GMAHA's vision is to create an attractive multifaceted neighborhood community redevelopment plan, strategically combining Project Based Section 8, multi-family, single-family, commercial development and mixed-income housing.

Respondents shall certify their ability to start work on development plans with the team immediately and should be prepared to present GMAHA with a staffing plan that addresses the needs of the project through various phases of construction activity.

E. EVALUATION PROCESS

Responses will be evaluated using the following factors and assigned values:

A. Qualifications, Experience, References and Corporate Information (55%)

1. Provide a brief description of your Firm, including but not limited to the following:
 - a. Name of the Principal(s) of the Firm
 - b. Name, telephone number and email address of a representative of the Firm authorized to discuss your proposal
 - c. Address of all offices of the Firm
 - d. Number of employees of the Firm
2. Experience and Resources:
 - a. Describe your Firm and its capacity to perform the Scope of Services
 - b. Support your capacity to indicate which principals and associates from your Firm will be involved in providing the GMAHA with services. Provide appropriate background information for each such person and identify his/her responsibilities
 - c. Provide a detailed list of references, including a contact name and telephone number for five **(5)** organizations or businesses for whom you have provided LIHTC/HUD Contractor Services to completed status
 - d. Identify any conflict of interest that may arise as a result of business activities or ventures by your Firm and associates of your Firm, employees or subcontractors as a result of any individual's status as a member of the Board of Directors of any organization likely to interact with the Greater Metropolitan Area Housing Authority of Rock Island County.
3. Demonstrate your Firm and assigned professionals' experience with the following:
 - General Contracting regarding the LIHTC programs;
 - General Contracting regarding HUD Sponsored programs or mortgages
4. Illinois Experience
 - Identify your Firm's relevant experience and that of any assigned professionals in Illinois or the surrounding area
 - Must be in good standing with the Illinois Housing Development Authority and Housing and Urban Development
 - Identify any additional references relating to Public Housing Agencies with contact information
 - Identify the types of services provided

B. Basis and Calculation of Fees (15%)

1. The General Contractor will agree to conform to the GMAHA's Limitations for Builder's Overhead & Profit of construction hard costs and General Requirements for new construction and rehabilitation projects; including all change orders.
2. There will be no increase to the Overhead and Profit or General Requirements other than what is approved by change orders during the course of the project. There will be no change orders approved solely to increase Overhead and Profit or General Requirements. At project completion, the Overhead and Profit and General Requirements may not exceed the limitations allowed by the GMAHA.
3. Please provide any other fee information applicable to the engagement that has not been previously covered that you wish to bring to the attention of the GMAHA.

C. Capability for Timeliness (20%). Please provide your commitment to be able to immediately commence the engagement should you be retained to serve as the General Contractor / Construction Manager.

D. General Quality of the Response to the RFP (10%). This factor will be rated for the written response for any interviews that might be conducted.

E. Section 3 Criteria (15% bonus). This factor requires that recipients of certain HUD financial assistance, to the greatest extent feasible, provide job training, employment and contracting opportunities for low or very low-income residents in connections with projects and activities in their neighborhoods.

F. DISCLOSURES

Under the Freedom of Information Act (Public Act 442), the GMAHA is obligated to permit review of its files, if requested by others. All information in a submitter's proposal is subject to disclosure under this provision. This act also provides for a complete disclosure of contracts and attachments thereto.

G. RIGHT TO REJECT PROPOSALS

The GMAHA reserves the right to award the total proposal, to reject any and all proposals in whole or in part, and to waive any informality or technical defects if, in the GMAHA's sole judgment, the best interests of the GMAHA will be so served.

H. COST LIABILITY

The GMAHA assumes no responsibility or liability for costs incurred by the consultant prior to the execution of a Professional Services Agreement. The liability of the GMAHA is limited to the terms and conditions outlined in the Agreement.

RESERVATION OF RIGHTS

1. The GMAHA reserves the right in its sole and absolute discretion to accept or reject any or all Proposals or alternative Proposals, in whole or in part, with or without cause.
2. The GMAHA reserves the right to waive or not waive informalities or irregularities in bids or bidding procedures, and to accept or further negotiate cost, terms, or conditions of any bid determined by the GMAHA to be in the best interests of the GMAHA even though not the lowest bid.
3. The GMAHA reserves the right to request additional information from any or all Bidders.
4. The GMAHA reserves the right not to consider any Proposal which it determines to be unresponsive and deficient in any of the information requested within the RFP.
5. The GMAHA reserves the right to determine whether the scope of the project will be entirely as described in the RFP, a portion of the scope, or that a revised scope be implemented.
6. The GMAHA reserves the right to select one or more Bidders to perform services.
7. The GMAHA reserves the right to retain all proposals submitted and to use any ideas in a proposal regardless of whether that proposal is selected. Submission of a proposal indicates acceptance by the firm of the conditions contained in this Request for Proposals, unless clearly and specifically noted in the proposal submitted.
8. The GMAHA reserves the right to disqualify Proposals that fail to respond to any requirements outlined in the RFP, or for failure to enclose copies of the required documents outlined within the RFP.
9. A respondent's failure to provide accurate information in response to this RFP may disqualify the respondent from further participation in the selection process. Proposals may be corrected, modified or withdrawn, provided that the correction, modification or request for withdrawal is made by the respondent, in writing (e-mail accepted), and is received by GMAHA prior to the Proposals submission deadline. After such date and time, the respondent may not change any provision of their response in a manner detrimental to the interest of GMAHA and/or fair competition.
10. The key personnel specified by the successful respondent will be considered essential to the work to be performed by the successful respondent. Prior to diverting any of the key personnel for any reason(s), the contractor shall notify GMAHA in writing, at least thirty (30) calendar days in advance, and shall

submit justification (including proposed substitutions) in sufficient detail to permit evaluation of the impact on the contract. Changes in personnel may be grounds for contract termination.

11. GMAHA is not liable for any costs incurred by the respondents prior to issuance of a contract. The respondents shall wholly absorb all costs incurred in the preparation and presentation of the RFP and oral presentation.

J. SUBMISSION REQUIREMENTS

Responses that do not include all required information may be deemed unresponsive. Each respondent is required to submit a response providing information on the following items:

- 1) Letter of Interest: Respondent's submittals shall be accompanied by a Letter of Interest on the respondent's letterhead. The letter should state proposer understands the scope of services, the commitment to perform the services expeditiously, and a brief statement indicating why the respondent believes they are best qualified to perform the engagement. The letter shall be signed by an authorized signor.
- 2) Respondent's Qualifications: **The respondent shall submit the following information regarding its qualifications and should use the same number and title for each corresponding response** (to simplify review):
 - a) **Previous Housing Development General Contracting Experience**
 - i) Please use Attachment I to respond to this item (one form per project). Provide information on up to five (5) residential rental development/revitalization projects in which the respondent has participated. Attempt to provide the most recent projects and the most pertinent to GMAHA's scope.
 - b) **Organizational Structure and Profile of Principals and Key Staff**
 - i) Provide a description or chart of the organizational structure and staffing of the respondent's team.
 - ii) Provide profiles of the principals and key staff that will be involved in the development's construction management effort, what roles they would serve for GMAHA, and their level of experience as a project manager and project superintendent and project engineer. Highlight their involvement in similar projects and activities
 - iii) Provide resumes of their experience in managing construction projects for any public housing authority and/or multifamily revitalization projects which include demo / disposition, new construction and building rehabilitation. List all projects that have been completed using funding from Section 42 tax credits (9 or 4%) in any state. List all publicly funded multifamily projects completed within the last ten (10) years.
 - iv) Certify that all key staff will be available to start immediately or describe existing

time commitments which would impair the respondent's ability to proceed expeditiously.

1. Certificate of Independent Price Determination

(a) The bidder certifies that--

(1) The prices in this bid have been arrived at independently, without, for the purpose of restricting competition, any consultation, communication, or agreement with any other bidder or competitor relating to (i) those prices, (ii) the intention to submit a bid, or (iii) the methods or factors used to calculate the prices offered;

(2) The prices in this bid have not been and will not be knowingly disclosed by the bidder, directly or indirectly, to any other bidder or competitor before bid opening (in the case of a sealed bid solicitation) or contract award (in the case of a competitive proposal solicitation) unless otherwise required by law; and

(3) No attempt has been made or will be made by the bidder to induce any other concern to submit or not to submit a bid for the purpose of restricting competition.

(b) Each signature on the bid is considered to be a certification by the signatory that the signatory--

(1) Is the person in the bidder's organization responsible for determining the prices being offered in this bid or proposal, and that the signatory has not participated and will not participate in any action contrary to subparagraphs (a)(1) through (a)(3) above; or

(2) (i) Has been authorized, in writing, to act as agent for the following principals in certifying that those principals have not participated, and will not participate in any action contrary to subparagraphs (a)(1) through (a)(3) above.

(ii) As an authorized agent, does certify that the principals named in subdivision (b)(2)(i) above have not participated, and will not participate, in any action contrary to subparagraphs (a)(1) through (a)(3) above; and

(iii) As an agent, has not personally participated, and will not participate in any action contrary to subparagraphs (a)(1) through (a)(3) above.

(c) If the bidder deletes or modifies subparagraph (a)2 above, the bidder must furnish with its bid a signed statement setting forth in detail the circumstances of the disclosure.

(d) Non-collusive affidavit. (applicable to contracts for construction and equipment exceeding \$50,000)

(1) Each bidder shall execute, in the form provided by the PHA/IHA, an affidavit to the effect that he/she has not colluded with any other person, firm or corporation in regard to any bid submitted in response to this solicitation. If the successful bidder did not submit the affidavit with his/her bid, he/she must submit it within three (3) working days of bid opening. Failure to submit the affidavit by that date may render the bid nonresponsive. No contract award will be made without a properly executed affidavit.

(2) A fully executed "Non-collusive Affidavit" [] is, [] is not included with the bid.

2. Contingent Fee Representation and Agreement

(a) Definitions. As used in this provision:

"Bona fide employee" means a person, employed by a bidder and subject to the bidder's supervision and control as to time, place, and manner of performance, who neither exerts, nor proposes to exert improper influence to solicit or obtain contracts nor holds out as being able to obtain any contract(s) through improper influence.

"Improper influence" means any influence that induces or tends to induce a PHA/IHA employee or officer to give consideration or to act regarding a PHA/IHA contract on any basis other than the merits of the matter.

(b) The bidder represents and certifies as part of its bid that, except for full-time bona fide employees working solely for the bidder, the bidder:

(1) [] has, [] has not employed or retained any person or company to solicit or obtain this contract; and

(2) [] has, [] has not paid or agreed to pay to any person or company employed or retained to solicit or obtain this contract any commission, percentage, brokerage, or other fee contingent upon or resulting from the award of this contract.

(c) If the answer to either (a)(1) or (a)(2) above is affirmative, the bidder shall make an immediate and full written disclosure to the PHA/IHA Contracting Officer.

(d) Any misrepresentation by the bidder shall give the PHA/IHA the right to (1) terminate the contract; (2) at its discretion, deduct from contract payments the amount of any commission, percentage, brokerage, or other contingent fee; or (3) take other remedy pursuant to the contract.

3. Certification and Disclosure Regarding Payments to Influence Certain Federal Transactions (applicable to contracts exceeding \$100,000)

(a) The definitions and prohibitions contained in Section 1352 of title 31, United States Code, are hereby incorporated by reference in paragraph (b) of this certification.

(b) The bidder, by signing its bid, hereby certifies to the best of his or her knowledge and belief as of December 23, 1989 that:

(1) No Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress on his or her behalf in connection with the awarding of a contract resulting from this solicitation;

(2) If any funds other than Federal appropriated funds (including profit or fee received under a covered Federal transaction) have been paid, or will be paid, to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress on his or her behalf in connection with this solicitation, the bidder shall complete and submit, with its bid, OMB standard form LLL, "Disclosure of Lobbying Activities;" and

(3) He or she will include the language of this certification in all subcontracts at any tier and require that all recipients of subcontract awards in excess of \$100,000 shall certify and disclose accordingly.

(c) Submission of this certification and disclosure is a prerequisite for making or entering into this contract imposed by section 1352, title 31, United States Code. Any person who makes an expenditure prohibited under this provision or who fails to file or amend the disclosure form to be filed or amended by this provision, shall be subject to a civil penalty of not less than \$10,000, and not more than \$100,000, for each such failure.

(d) Indian tribes (except those chartered by States) and Indian organizations as defined in section 4 of the Indian Self-Determination and Education Assistance Act (25 U.S.C. 450B) are exempt from the requirements of this provision.

4. Organizational Conflicts of Interest Certification

The bidder certifies that to the best of its knowledge and belief and except as otherwise disclosed, he or she does not have any organizational conflict of interest which is defined as a situation in which the nature of work to be performed under this proposed contract and the bidder's organizational, financial, contractual, or other interests may, without some restriction on future activities:

- (a) Result in an unfair competitive advantage to the bidder; or,
(b) Impair the bidder's objectivity in performing the contract work.

5. Bidder's Certification of Eligibility

(a) By the submission of this bid, the bidder certifies that to the best of its knowledge and belief, neither it, nor any person or firm which has an interest in the bidder's firm, nor any of the bidder's subcontractors, is ineligible to:

(1) Be awarded contracts by any agency of the United States Government, HUD, or the State in which this contract is to be performed; or,

(2) Participate in HUD programs pursuant to 24 CFR Part 24.

(b) The certification in paragraph (a) above is a material representation of fact upon which reliance was placed when making award. If it is later determined that the bidder knowingly rendered an erroneous certification, the contract may be terminated for default, and the bidder may be debarred or suspended from participation in HUD programs and other Federal contract programs.

6. Minimum Bid Acceptance Period

(a) "Acceptance period," as used in this provision, means the number of calendar days available to the PHA/IHA for awarding a contract from the date specified in this solicitation for receipt of bids.

(b) This provision supersedes any language pertaining to the acceptance period that may appear elsewhere in this solicitation.

(c) The PHA/IHA requires a minimum acceptance period of [Contracting Officer insert time period] calendar days.

(d) In the space provided immediately below, bidders may specify a longer acceptance period than the PHA's/IHA's minimum requirement. The bidder allows the following acceptance period: calendar days.

(e) A bid allowing less than the PHA's/IHA's minimum acceptance period will be rejected.

(f) The bidder agrees to execute all that it has undertaken to do, in compliance with its bid, if that bid is accepted in writing within (1) the acceptance period stated in paragraph (c) above or (2) any longer acceptance period stated in paragraph (d) above.

7. Small, Minority, Women-Owned Business Concern Representation

The bidder represents and certifies as part of its bid/ offer that it --

8. Indian-Owned Economic Enterprise and Indian Organization Representation (applicable only if this solicitation is for a contract to be performed on a project for an Indian Housing Authority)

The bidder represents and certifies that it:

(a) ☐ is, ☐ is not an Indian-owned economic enterprise. "Economic enterprise," as used in this provision, means any commercial, industrial, or business activity established or organized for the purpose of profit, which is at least 51 percent Indian owned. 9. Certification of Eligibility Under the Davis-Bacon Act (applicable to construction contracts exceeding \$2,000)

(a) By the submission of this bid, the bidder certifies that neither it nor any person or firm who has an interest in the bidder's firm is a person or firm ineligible to be awarded contracts by the United States Government by virtue of section 3(a) of the Davis-Bacon Act or 29 CFR 5.12(a)(1).

(b) No part of the contract resulting from this solicitation shall be subcontracted to any person or firm ineligible to be awarded contracts by the United States Government by virtue of section 3(a) of the Davis-Bacon Act or 29 CFR 5.12(a)(1).

(c) The penalty for making false statements is prescribed in the U. S. Criminal Code, 18 U.S.C. 1001.

10. Certification of Nonsegregated Facilities (applicable to contracts exceeding \$10,000)

(a) The bidder's attention is called to the clause entitled **Equal Employment Opportunity** of the General Conditions of the Contract for Construction.

(b) "Segregated facilities," as used in this provision, means any waiting rooms, work areas, rest rooms and wash rooms, restaurants and other eating areas, time clocks, locker rooms and other storage or dressing areas, parking lots, drinking fountains, recreation or entertainment areas, transportation, and housing facilities provided for employees, that are segregated by explicit directive or are in fact segregated on the basis of race, color, religion, or national origin because of habit, local custom, or otherwise.

(c) By the submission of this bid, the bidder certifies that it does not and will not maintain or provide for its employees any segregated facilities at any of its establishments, and that it does not and will not permit its employees to perform their services at any location under its control where segregated facilities are maintained. The bidder agrees that a breach of this certification is a violation of the Equal Employment Opportunity clause in the contract.

(d) The bidder further agrees that (except where it has obtained identical certifications from proposed subcontractors for specific time periods) prior to entering into subcontracts which exceed \$10,000 and are not exempt from the requirements of the Equal Employment Opportunity clause, it will:

(1) Obtain identical certifications from the proposed subcontractors;

(2) Retain the certifications in its files; and

If the successful bidder does not submit the certificate with his/her bid, he/she must submit it within three (3) working days of bid opening. Failure to submit the certificate by that date may render the bid nonresponsive. No contract award will be made without a properly executed certificate.

(b) A fully executed "Previous Participation Certificate"
